#### Keynote with Dr Joanna Miller-Smallwood

The Rights of Nature: Advocating for the rights of the Andean Bear in the Ecuadorian Andes and peaceful co-existence with local communities through the establishment of secure land tenure and sustainable livelihoods.

The Ecuadorian Andes is a global biodiversity hotspot, yet it is being deforested faster than most other places on earth, largely due to small-scale farming. Ecuador is a world leader in adopting constitutional provisions to protect the Rights of Nature (RoN) and has designated a network of protected forests, which are vital for the survival of the Andean (Spectacled) bear. However, these measures are often perceived locally as undermining the livelihood needs of local farmers and contributing to increased human-wildlife conflicts. Based on collaborative research with rural communities, alongside legal experts, local NGOs, and government agencies, this project addresses these issues by assessing the impact of land legalization processes and the RoN on local communities and conservation. Additionally, it will consider whether a novel RoN approach centered on individual animals has the potential to reduce socio-economic inequalities while improving wild animal welfare.

## Speaker Information



#### Dr Joanna Miller-Smallwood

Joanna is an associate professor and lawyer with a long-standing interest in nature conservation, animal rights and law. Her recent book: Implementing International Environmental Law and Policy: An Interactive Approach to Environmental Regulation (Routledge, 2024) focuses on transformative governance, she has also written on transformative governance of food production and consumption, tropical forests, invasive alien species and nature conservation. Her recent interests are on implementing legal and policy frameworks for the Rights of Nature in Brazil, Ecuador, Colombia and in the UK. She is developing a Rights of Trees, Woodlands and Forests toolkit with her students. She has been awarded funding and the 2024 Sussex University research culture award for her transdisciplinary work on the rights of the Andean bear in Ecuador. She is also involved in using a rights of nature approach in international biodiversity law for transformative governance.



#### Dr Evan Killick

Evan is a Social Anthropologist by training who now conducts research and teaching in both Anthropology and International Development. He has over two decades of experience working with forest-based communities across Latin America. This work has included projects in Brazil, Bolivia, Ecuador and Costa Rica but his core focus remains with Indigenous Peoples in Peruvian Amazonia.



#### **Dr James Morland**

James is a research impact manager at the University of Sussex, where he acts as one of Sussex's subject matter experts in research impact and works across the university to promote good knowledge of the significance and nature of research impact. Before coming to Sussex, he was a postdoctoral researcher on the Wellcome-funded 'Pathologies of Solitude' project at Queen Mary, University of London where he worked on various public facing activities.



#### **Dr Emily Danvers**

Emily is a Senior Lecturer/Associate Professor in Education. Her research interests are in the context, purpose and values of higher education and, specifically, questions of equity and social justice. She is an experienced research writing facilitator, with a passion for supporting students' learning.



#### Dr Smadar Cohen-Chen

Smadar believes that social and organizational issues cannot be fully understood without considering psychological factors and phenomena. She asserts that psychology loses much of its relevance if it does not address real questions regarding the dynamics between people and groups. Her research focuses on the role of emotions in decision-making, conflict resolution, leadership and management, and negotiations. This includes both emotional experiences and emotional expressions. Dr. Cohen-Chen's work spans organizational, social, and political contexts, examining how these frameworks influence one another.



#### Dr Raluca Popp

Through her involvement in the Industry and Doctoral Training Network (Marie Curie), Raluca developed an expertise in Voting Advice Applications (VAAs) and the use of large-scale datasets generated by these digital tools. Her research leverages VAAs to address key questions, such as examining issue alignment in European Parliament elections. She is also interested in a range of methodological issues and techniques related to online samples, such as multilevel regression and postratification. Since joining Kent, Raluca has become an integral part of the Conflict Analysis Research Centre. With a keen interest in experimental methods, she is now applying conjoint analysis in conflict studies, focusing on citizen preferences for peace settlements and the potential for public engagement in peacebuilding initiatives.



#### Prof Emily (Jintao) Ma

Emily is a Professor at the School of Hospitality & Tourism Management, the University of Surrey, UK. Her research area includes organizational behaviour, customer experience management and women in leadership. Her most recent research looks at how robots can be applied in hospitality and tourism contexts to enhance employee well-being and customer experience.

#### Meals


Dinner on Tuesday is being hosted in the Falmer Bar, and you will be given a meal voucher during Day 1 Registration.

### **Elevator Pitch Information Sheet**

This session is all about explaining your research concisely and engagingly. You'll each have **1 minute** and **1 slide** to 'pitch' your PhD project, followed by a short Q&A.

Think poster-style, but adapted to slide format, so keep text clear, fonts large (over 20) and avoid complicated jargon. This is your chance to explain what you're working on, why it matters, and where it could go. Aim to be clear, concise, and engaging.

Pay close attention to your peers: during the Student Elevator Pitch Challenge, you'll identify colleagues whose research aligns with yours for potential interdisciplinary collaboration.
